

Popular Guest Speaker, Jim MacMillan, CVSE Addresses Topic Of **Infrastructure Crashes At March Meetings.**

Topic:

CVSE bulletin #07-2023 published Dec 14 2023;

All three regulations in this bulletin are a result of commercial vehicle infrastructure crashes causing damage, stop the movement of people and goods and increase safety risk for everyone on the road.

The ministry is implementing measures to further deter these incidents and respond to stronger enforcement when they occur.

1. Over height regulations

New orders and higher fines for over-height related offenses. Order #718-2023 (a) and #719-2023 (a) effective Dec 14 2023.

What does this regulation mean, and what happens to the carrier if one of their drivers damages an overpass.

2. Speed limiter mandate

Implementation and enforcement of speed limiters for heavy duty vehicles. Order # 720-2023 (b) and #720-203 (c) effective April 2024.

What does this regulation mean, and what effect it has on fleets, and which fleets are affected? Limiting speed will increase deliver times.

3. In-cab warning devices

Installation of in-cab warning device mandate for certain commercial vehicles with dump boxes. Order #718-2023 (b) and #719-2023 (b) effective June 1 2024.

What does this regulation mean, how does it affect new dump truck purchase? Do older units need retrofitting?

Air Brake Instructor Certification

A Provincial Government Approved Course

This ICBC approved program is designed to give participants the knowledge to effectively prepare and deliver an air brake course.

The course concentrates on instructional methods and technical content for air brake systems.

Course content includes topics of instructional procedures such as lesson plans, coaching, effective teaching techniques, questioning techniques and developing multiple choice questions.

Technical content includes topics on the basic air brake system, dual air brake system, trailer air brake systems, brake adjustment and air brake valves.

Each student is given an opportunity for "hands on" experience in assembling and instruction using a fully operational air brake board. The air brake board has fully interchangeable components and is capable of simulating all types of air brake systems.

Each student is required to develop and present two 45 minute presentations to the class. Topics will be on air brake systems and the instructor will allocate the topics on the first day of class.

Each student must obtain 80% on each presentation to pass the course. An informational entrance exam is given on the first day and a final theory exam is given at the end of the week. Each participant must obtain 80% on the final theory exam to be successful.

Each student is given a "Driving Commercial Vehicles" handbook, a course manual which includes technical information and Provincial And Federal air brake regulations.

IMPORTANT ACTION REQUIRED BY STUDENT:

To confirm the two years of air brake experience, the applicant will need to obtain a customized Driver's Abstract with a note added to their driving record which displays the date they received their (endorsement 15) air brake endorsement.

The applicant must phone ICBC to get this customized driving record emailed or mailed to them.

Regular online driving records or those produced at a Driver Licensing Office will not have this information.

Once copy is obtained, you may proceed to register.

Authorized Inspector Program Course Provincial Government recognized Certification Course upon successful completion

This course is required for journey person mechanics wanting to become certified as an Authorized Commercial Motor Vehicle Inspector.

This 3-day course will include two days of theory and one day of practical.

Prerequisites include Certificate of Qualification (TQ#) or Red Seal status in Commercial Transport Mechanical Repair, Commercial Transport Trailer Repair, Heavy Duty Mechanical Repair or Automotive Repair Trades.

Participants are eligible to receive Authorized Inspector Program Certification upon successful completion of the course.

This course will cover the following content:

- Classes of motor vehicles,
- Motor Vehicle Act and Regulations,
- · Designated Inspection Facility Program,
- · Preventative Maintenance Program,
- · Inspector Qualifications and Responsibilities,
- Responsibilities of Facility Operators and Inspectors,
- · Commercial Vehicle Inspection manual,
- Procedures for forms completion and decal application,
- · Vehicle Inspection e-forms general procedures and how to sign up,
- Preparation and administration of Authorized Inspectors examination,

NOTE student requirements:

A mobile BC Services Card registered for use to access online government application https://www2.gov.bc.ca/gov/content/ governments/government-id/bc-services-card/log-inwith-card

Student are required to bring to class a laptop computer, tablet or mobile device to take the examination and apply for their inspector certificate.

CSA approved safety glasses and footwear is required during the practical portion of the course. Footwear must be steel-toed leather, ankle covering boots.

CAFS Strong After 75 Years!

We continue CAFS Historical Review with CAFS Past Presidents and their contributions to our Association.

Past President Al Chorny continues to contribute to CAFS history by writing articles for both the 60th and 70th anniversary celebrations. Here is Al's account of his tenure as CAFS president in 1983 written for the CAFS 70th year booklet.



Good evening ladies & gentlemen:

I can still remember my first introduction to the Canadian Association of Fleet Supervisors, way back in 1966. Fred Zelisko, then Chassis Foreman at Freightliner of Canada was very involved with the annual truck driving championships. He looked me right in the eye one day and said, "You're volunteering".....and that's how it all started.

The driving championships were soon moved from the Sears parking lot, which is now Metrotown, to the Richmond Centre lot. At the time, this event involved less than one day, with the department store step -in van drivers outnumbering everyone else. We had competitors from Sears, Eaton's, Woodwards, The Bay, and numerous small fleets in the lower mainland.

In Richmond, we introduced a small display section where the truck manufacturers showed their latest models. Getting any kind of newspaper coverage to promote the event was really difficult. Harry Bohart from Palm Dairies suggested a "beauty Queen contest" as he was already involved with the Miss PNE pageant. As a result, that became his responsibility, and newspaper coverage was easily gained. We had the pleasure of a Mountie dressed in his Red Serge who joined the festivities and accompanied the various beauty contestants.

The Truck Driving Championships progressed further to include entertainment, and more expansion of the vehicle displays, to a point where we found it necessary to move on to the larger Boundary Bay Airport. This was now a major event, consuming all of four days. An Awards Banquet was scheduled a week later at various hotels over the years.

At one point, Fred Zelisko exclaimed, "This has now turned into a circus!" We did, however, have a lot fun with a fabulous committee who brought, for the first time to the West, the Canadian Professional Truck Driving Championships. One of the highlights of our endeavours was Mr. Denny Kohn of Shell Oil who went on to represent Canada in the World Truck Driving Championships in Paris, France.

I had the pleasure of being the Chairman for the British Columbia and Canadian Truck Driving Championships, and was nominated for the position of President of the CAFS in 1983 which I held for one year.

1983 saw a challenge in locating suitable space for our driving championships as most parking lots were

built with islands and lighting towers which prevented us from having many of the previously held events. The President of the B.C. Trucking Association, Mr. Bill Gartside, made the CAFS an offer to join forces with them and thereby receive a \$10,000 grant. This was a hot topic and discussed at great length among our committee, but the conclusion was that his offer was not accepted.

1984 saw Freightliner of Canada being purchased by Daimler Benz of Germany, and thus my work load at Freightliner increased immensely. For that reason, my association with the CAFS became quite limited.

With much enjoyment, I look back now at all the interesting times, and various people that I met during those years, many of whom became lasting personal friends.

I am sorry that it is not possible for me to attend the 70th Anniversary, but I offer my congratulations and best wishes for continued success in the future.

The Early Days...

The following is Lisle Plaskett's recollection of the very early days of the C.A.F.S. entry

My father, Jim Plaskett, Executive Secretary of Vancouver Traffic & Safety Council, was one of the early members. He also acted as Executive Secretary for C.A.F.S., who operated out the Vancouver Traffic & Safety Council offices. At that time, it was known as the Fleet Supervisors Association, the C.A.F.S. not being adopted until considerably later when we hooked up with the Seattle and Portland groups.

Lisle, at the age of 15, with a new driver's license in hand competed in the 1950 Second Annual High School Driver Roadeo, then run by the association, as well as the B.C. Truck Roadeo. Both were located on the parade square of the Seaforth Armouries. Lisle with a rocket nosed Studebaker placed second. The winner was Ron Defleux, driving a

Lisle tells us the cost of driver training in 1950 was \$4.00 and included a text book and five hours training in a vehicle (the fifth hour being the road test). This gave him an immediate 20% discount on his auto insurance premium.

From 1950, with his father's prodding, Lisle became involved with the BC Truck Roadeo as judge, timer and anything else that needed attention. From the Seaforth Armouries, the Roadeo was moved to the Sear's parking lot. During those years Lisle was employed by the electronics industry. In 1956 he was employed at B.F. Goodrich's store, 275 Kingsway, where H.A. (Hec) Irving was manager and very active in the Fleet.

From electronics he moved to Brandtford Coach and Body Ltd. where the manager was R.E. (Bob) Sparling. At this time Lisle became a member of the Fleet Supervisors Association. Shortly after he served on the directors for seven years.

The Fleet senior powers in the later 50's / early 60's were very dedicated. They were Harry Roberts and Al Whitehead of Pacific Cartage, Harry Burns of Bowman's Cartage & Storage, Colin Dobell of B.C. Hydro, Bill McKinley of McKinley Driving School, Gord Winton and Cy Fishburne of Country Freight Lines, Bob Mills of Burrard Cartage, Hec Irving, later of Irving Tire, and Bob Sparling, later of Pacific GMC and Cullen Detroit Diesel Allison.

In 1961 Lisle returned to the electronics trade only to go back to Brantford Coach and Body Ltd. In 1963 he took on management of Brittain Diesel. This exposed him to the logging industry and the Squamish area. With the help of Al Chorny of Freightliner and Dave Reid of Ron McCormick Trucking, the Logging Truck Roadeo became the competition still held annually in conjunction with the Squamish Loggers Sports Day.

In 1967, Lisle was the Fleet's photographer for the Truck Roadeo, until his retirement in

The Roadeo saw many venues since the Seaforth Armouries and Sears, through Oakridge Shopping Centre, Richmond Mall, Dorman Marpole Transport, Boundary Bay Airport, the Cloverdale Fairgrounds and the Abbotsford grounds.

Somewhere in the past the Roadeo was managed by BCMTA (now BCTA) who dropped the ball and left it to be resurrected by the Fleets-and we did a hell of a job!

I remember this Roadeo well as I had parked in the wrong place at the Carson Terminal, and when I went to go home, my car had disappeared. George gave me a parking ticket, fined me \$30, and, at Christmas time, I received a receipt from a charity. I made sure in the future that I always parked in the right spot.

Through the above individuals, I was able to meet the Presidents of these companies and many of them placed their insurance with us. To this day we still insure many of these operations.

Fleet Supervisors was a great learning ground, the camaraderie was second to none, and if I had to do it all over again, I would go down the same road.



History in the waking. . .

The Maintenance Conference was a gem of an idea Al Chorny and I had, after being involved with the annual Seattle Maintenance Conference. We thought it might be nice to have a one day deal for the people who could not afford to spend four days in Seattle. It was an immediate success and developed into two days. This major achievement commenced in late 1972.

In October 1981, the C.D.I.C. (Commercial Driver Improvement Course) was the brain child of a few members who thought it would be good to have a trucker's version of the Defensive Driving Course. The R.C.M.P. had a terrific in-house five day course on Instructional Techniques. They offered it to us along with two very competent instructors, Dennis Garrett and Keith McMurchy. About twenty of us attended. Then we set about, once a week for months, gathering information, tracking down videos, equipment and financing. The Motor Vehicle Branch loved the idea and gave us their full approval. Lafarge Concrete gave us a no-interest loan, I don't remember how much, but it was a beauty. We got help from everyone in the industry with what we needed to float this thing, and the results speak for themselves.

With help from people like John Webb, Fergus Savage, and Ted Hrynew, we linked up with N.W.A.F.S. (Northwest Alliance of Fleet Supervisors), which brought us no monetary rewards, but kept us in touch with all the goings on down South.

The Air Brake Instructors course came about in the early seventies after licenses changed from the A.B.C. to the six number classification, and the need arose to acquire air-brake training. President Ed Thompson and Board of Directors at that time, in discussions with the MVB, asked Al Wright to put on air brake instructor courses. Al had multi years experience repairing and troubleshooting air equipment, and is still the North American expert to put on a training program. Al, being as dedicated as he is, chose to do it through C.A.F.S., it was then the Safety Council. I was blessed in that Al took me under his wing, and asked me to help him get it going. I can't even shine the guy's shoes when it comes to experience. I felt small standing next to Al and I certainly owe Al a debt of gratitude for allowing me to work with him. He supported me all the way, and we have stayed friends and talk regularly.

The offshoot of all this is that C.A.F.S. was able to negotiate a deal with Department of National Defense for an annual Air-brake instructors course in Victoria for there would be instructors from across Canada. The neat part was that they already had qualified instructors who had passed our course but D.N.D. did not want to be labeled as bypassing regulations by going in-house, and wanted recognition and certificates issued from B.C. DND's top instructor would put all the students through one week of intensive training, then Al would go over for five days and smooth off the rough edges, and certify them. When Al was subpoenaed to testify at the Kamloops inquest, he had me go over and complete it for him. This provided a good source of revenue for C.A.F.S.

When I was President in 1985, I initiated a Good Joe Award, from something I saw on TV one evening. It was for someone who worked on and off the scene all year, but received no recognition. Gordon Smith was the first recipient. It somehow got coordinated with the Roadeo, and became a Roadeo event. It was originally begun as a memory of Cy Fishburne, but lost its shine through a couple of occurrences. It was not meant specifically for one sex or event, rather for C.A.F.S. in all its events, however, it got stuck with the Roadeo and only men won it. So Doug Wilson suggested a Good Jane award and Dairyland would sponsor it. This was well received. It was offered in memory of his wife who had attended some of the Fleet's gatherings. It was a nice gesture and you had to admire Doug for his feelings.

Then at a later Roadeo, Norm Coridor as Roadeo Master, decided that everyone worked equally well, and the Good Joe/Jane award would be a community award. However, it really does not mean much anymore, if in fact it still exists. No one worked harder than Ted Hrynew, Bruce McKenzie, Earl Strong, Al Wright, Lee Wetmore, and a host of people too numerous to mention but it became a Roadeo thing, and like most things, it got lost somewhere along the way.

With the help from people like John Tessier, Bob Milroy, and countless others, we put on some pretty successful car rallies. The most fun came from the likes of Lee Wetmore and friends, who always got lost, and rode the Langley ferry back and forth trying to tie in some ferry numbers, and then got lost so they ended up in Blaine and said to Hell with it, and spent the rest of the night in the pub. Or the one where John Tessier had everyone trying to find dead centre of Fort Langley and it was the graveyard. The nicest one of all was when they had to count the pickets on this particular fence, and the elderly lady who lived there alone said she hadn't had that much company in years and set up a table with cold drinks and cookies and helped everyone count the pickets. Also the year when one of the prizes was a light bulb, our daughters kept my home doors open and they cleaned us out of light bulbs.

I would be remiss in not mentioning the support I received from Trans Power Construction. I was never questioned about the money I spent or the time I took away from the job for the Fleet's organization. They always said it was money well spent and presented the company in a favourable light.

We put in a display and program ad every year, as did many others, we supplied vehicles anytime it was necessary, and as well, we supplied two-way radios every year, which incidentally were all stolen one year in a truck break-in. Insurance did not cover the radios because they were not being used on a company job. Every list of roadeo equipment, except for a few pieces of donated angle irons, from barricades, diminishing clearance flags, etc., etc., were all built and painted in my shop at the company's expense.


